These images cover races from various series such as SCCA, Trans-Am, ARRC, and NASCAR GT 300. Notable venues photographed in this collection include Watkins Glen Circuit, Daytona International Speedway, Lime Rock Park, and Lake Garnett. This collection contains notable events including Watkins Glen 6 Hours, United States Grand, and SCCA National. Bob Hines photographs are not available on the <u>Revs Digital Library</u> at this time.

**Biography:** There is no biographical information available at this time.

**Scope and Content Note:** The Bob Hines Photographs are organized into three series separated by format:

**Series 1:** Contains 1,019 black-and-white negatives (1 clamshell binder box). Included are images of events such as the National Champion ARRC. Series 1 also consists of images of Daytona International Speedway and Shelby County International Raceway. Also included are a variety of miscellaneous and race action images.

**Series 2:** Contains 1,266 color transparencies (4 clamshell binder boxes). Included are images of events such as Watkins Glen 6 Hours, United States Grand Prix, SCCA National Road Atlanta, Trans-Am Series Lime Rock, and NASCAR GT 300.

**Series 3:** Contains an external hard drive (1 flat box) of digitized images that came with the Bob Hines photographs, 1959-1978. It is assumed that these images are digital copies of the physical black-and-white negatives and color transparencies.
